WHEREAS:

Late Digambarrao Bindu Smarak Samiti's Digambarrao Bindu Arts, Commerce & Science College, Bhokar. Dist. Nanded Maharashtra is an institute working in the field of Education since 1989. The College is recognized by the UGC under section 2 (f) and 12 (B). It has also got permanent affiliation of Swami Ramanand Teerth Marathwada University Nanded. The focused area of the institute is Education, Research and Extension. The college bagged B grade with an institutional score of 2.40 in the IInd Cycle of NAAC accreditation in 2016. The College offers B.A. B.Com. and M.Com, B. Sc. programmes with various courses in chemistry on the undergraduate level.

WHEREAS:

Chatrapati Sambhajiraje Multipurpose Service oriented Organization Lingapur's Rashtramata Jijau Soil and Water Testing Laboratory Lingapur Tq: Hadgaon Dist: Nanded is a laboratory run that works in the field of water and soil testing, water conservation, etc. The laboratory has established advance mechanism for soil testing.



The department of Chemistry at Digambarrao Bindu College Bhokar and Rashtramata Jijau Soil and Water Testing Laboratory Lingapur Tq: Hadgaon Dist: Nanded share common interests in the area of soil testing. As both the institutes have many areas of common interest in testing, research, and extension services considerable advantage may be gained from their pursuit on a collaborative basis in the said fields.

Now therefore, both the institutes have decided to enter into this Memorandum of Understanding (MoU), which defines the framework for the cooperation in a mutually beneficial association have agreed that:

The two institutions agree to have mutual exchange/access to:

- The department of Chemistry, Digambarrao Bindu ACS College Bhokar will provide guidance about theoretical issues involved in soil and water testing to the technicians at the Rashtramata Jijau Soil and Water Testing Laboratory Lingapur as and when required with prior appointment.
- The Rashtramata Jijau Soil and Water Testing Laboratory Lingapur will provide access to the soil testing laboratory to the students of the department of Chemistry, Digambarrao Bindu ACS College Bhokar.
- The Rashtramata Jijau Soil and Water Testing Laboratory Lingapur will accept and analyze soil samples sent by the department of Chemistry, Digambarrao Bindu ACS College Bhokar.

Details of any other activities will be subject to a separate Agreement.

1. The two institutions shall decide through consultation the specific areas and details of co-operation within the framework of this Agreement and shall consult each other mutually from time to time at the request of either institution for the purpose of reviewing the operation of this Agreement.
2. The financial arrangements involved in the implementation of this Agreement shall be settled through consultation between the two institutions in respect of each program area of co-operation.
3. The Agreement shall become operative on the last date indicated here under and shall remain


in force for a period of Three (3) years with an option to renew it for another three (3) Years.

4. This Agreement may be amended and supplemented by agreement between the two institutions. Either institution may terminate this Agreement by giving six (6) months notice in writing to the other institution. Any projects, training, or exchange that may have commenced at either institution before the date of termination may be completed by special agreement between the two institutions. For conditions not covered by this Agreement, or for problems that arise during the course of this Agreement, both parties undertake to refrain from unilateral action and to consult and negotiate mutually acceptable decisions.
5. The institutions shall confer concerning the renewal of this Memorandum of Understanding six (6) months prior to the date of expiry.




