WHEREAS:

Digambarrao Bindu Arts, Commerce & Science College Bhokar, Dist: Nanded is run by the parent institution Late Digambarrao Bindu Smarak Samiti Bhokar Dist. Nanded. The college



has a glorious history of its own. It was founded 1989 offering under graduate courses in arts and commerce. It was affiliated to Marathwada University Aurangabad from June 1989 till 1994. It is affiliated to Swami Ramanand Teerth Marathwada University Nanded from establishment of the university in 1994. In 2011 the college started offering B.Sc. courses. The college has reaccredited by NAAC with 'B' Grade CGPA 2.40 in the second cycle.

As both the colleges have many areas of common interest in academic, education and research, considerable advantage may be gained from their pursuit on a collaborative basis in the said fields.

Now therefore, both the colleges have decided to enter into this Memorandum of Understanding (MoU), which defines the framework for the cooperation in a mutually beneficial association have agreed that:

1. The two institutions shall encourage co-operation in the subject of Sociology that is studied in both institutions.
2. The two institutions shall seek to promote:
 - ✦ Exchange of information and materials that are of mutual interest.
 - ✦ Access to Research facilities & expertise for students and faculties.
 - ✦ Accommodation to the Visiting Scholars.
 - ✦ Organizing Guest Lectures.
 - ✦ Library Co-operation and Resources sharing.
 - ✦ Provision of briefing by each institution to visitors from the other institution.
 - ✦ Collaboration in organizing seminars, conferences, workshops etc.
 - ✦ Co-operation in career guidance and placement related activities




Details of any such activities will be subject to a separate Agreement.

3. The two institutions shall decide through consultation the specific areas and details of co-operation within the framework of this Agreement and shall consult each other mutually from time to time at the request of either institution for the purpose of reviewing the operation of this Agreement.
4. The financial arrangements involved in the implementation of this Agreement shall be settled through consultation between the two institutions in respect of each program area of co-operation.
5. The Agreement shall become operative on the last date indicated here under and shall remain in force for a period of Three (3) years with an option to renew it for another three (3) Years.
6. This Agreement may be amended and supplemented by agreement between the two institutions. Either institution may terminate this Agreement by giving six (6) months


notice in writing to the other institution. Any projects, training, or exchange that may have commenced at either institution before the date of termination may be completed by special agreement between the two institutions. For conditions not covered by this Agreement, or for problems that arise during the course of this Agreement, both parties undertake to refrain from unilateral action and to consult and negotiate mutually acceptable decisions.

7. The institutions shall confer concerning the renewal of this Memorandum of Understanding six (6) months prior to the date of expiry.
