

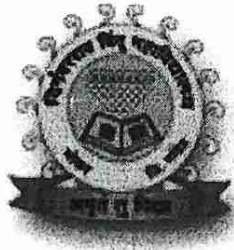

This Memorandum of Understanding has been signed between the department of Zoology, Late Digambarrao Bindu Smarak Samiti's Digambarrao Bindu Arts, Commerce & Science College, Bhokar. Dist. Nanded (MS) and Gauri Natural Foods, Chakur, Dist, Latur, Dist. Latur, on 04/ 02 /2019.

WHEREAS:

Late Digambarrao Bindu Smarak Samiti's Digambarrao Bindu Arts, Commerce & Science College, Bhokar. Dist. Nanded Maharashtra is an institute working in the field of Education since 1989. The College is recognized by the UGC under section 2 (f) and 12 (B). It has also got permanent affiliation of Swami Ramanand Teerth Marathwada University Nanded. The focused area of the institute is Education, Research and Extension. The college bagged **B** grade with an institutional score of 2.40 in the IInd Cycle of NAAC accreditation in 2016. The College offers B.A. B.Com. B. Sc. and M.Com programmes.

WHEREAS:

Gauri Natural Foods, Chakur, Dist, Latur, Dist. Latur is an Apiculture centre that works in the field of apiculture, bee cultivation, natural honey production, trading honey on wholesale and retail basis, and export of honey etc. The centre has established an advance mechanism apiculture.

The department of Zoology at Digambarrao Bindu College Bhokar and Gauri Natural Foods, Chakur, Dist, Latur, Dist. Latur share common interests in the area of apiculture and study of social behaviour of honey bees. As both the institutes have many areas of common interest in scientific study of insect behaviour research, and extension services considerable advantage may be gained from their pursuit on a collaborative basis in the said fields.

Now therefore, both the institutes have decided to enter into this Memorandum of Understanding (MoU), which defines the framework for the cooperation in a mutually beneficial association have agreed that:

The two institutions agree to have mutual exchange/access to:

- The department of Zoology, Digambarrao Bindu ACS College Bhokar will provide guidance about theoretical issues involved in apiculture to the technicians at the Gauri Nature Food's Apiculture Unit, Chakur, Dist. Latur as and when required with prior appointment.
- Gauri Natural Foods, Chakur, Dist, Latur, Dist. Latur will provide access to the different units of the apiculture Centre to the students of the department of Zoology, Digambarrao Bindu ACS College Bhokar.

Our students and faculties will be assisted to perform the following:

- To access to different processes involved in apiculture at the Centre.
- To study of social behavior of honey bees.
- To study the economic importance of apiculture.
- To conduct research work in class Hymenoptera.

Details of any other activities will be subject to a separate Agreement.

1. The two institutions shall decide through consultation the specific areas and details of co-operation within the framework of this Agreement and shall consult each other mutually from time to time at the request of either institution for the purpose of reviewing the operation of this Agreement.
2. The financial arrangements involved in the implementation of this Agreement shall be settled through consultation between the two institutions in respect of each program area of co-operation.
3. The Agreement shall become operative on the last date indicated here under and shall remain in force for a period of Five (5) years with an option to renew it

for another Five (5) Years.

- This Agreement may be amended and supplemented by agreement between the two institutions. Either institution may terminate this Agreement by giving six (6) months' notice in writing to the other institution. Any projects, training, or exchange that may have commenced at either institution before the date of termination may be completed by special agreement between the two institutions. For conditions not covered by this Agreement, or for problems that arise during the course of this Agreement, both parties undertake to refrain from unilateral action and to consult and negotiate mutually acceptable decisions.
- The institutions shall confer concerning the renewal of this Memorandum of Understanding six (6) months prior to the date of expiry.
