This Memorandum of Understanding (MoU) is made on January 02, 2020 between Asian Biological Research Foundation (ABRF) and Digambarrao Bindu Arts Commerce and Science College, Bhokar, Dist. Nanded for mutual cooperation witnesseth in academic exchanges, program development and research. This document establishes the guiding terms and principles of collaboration between the two organizations:

I. Legal Frameworks of Both the Organizations

Asian Biological Research Foundation (ABRF) is a nonprofit, non-Govt. and autonomous organization registered under the Act II of 1882, Govt. of India (Registration No.382) having it's regd. office at 14B/4A JLN Road Prayagraj, India.

Digambarrao Bindu Arts Commerce and Science College, Bhokar is an UGC 2(f) &12(b) approved, NAAC re-accredited B level and Govt. of Maharashtra aided college affiliated under the S.R.T.M University Nanded, having its campus at Bhokar Tahasil Dist Nanded, India.

II. Purpose of the Agreement

Given the interest of both organizations to establish ties of academic cooperation in order to contribute to the achievement of their overall goals as institutions of peace education, conflict resolution, disarmament studies etc., this agreement seeks to create a multi-disciplinary, multi-level relationship ABRF and Digambarrao Bindu Arts Commerce and Science College, Bhokar. It does not purport to prescribe areas of collaboration, but rather to provide a framework to facilitate the exploration of specific actions that may be taken for the mutual benefit of the two schools. Potential areas include, but are not limited to:

1. To share and exchange of knowledge in the fields of academics and research with the faculties, students and research scholars.
2. Cooperative development, collaboration and organize of various academic courses and programmes even with other organizations also.
3. Development of joint scientific and/or technological research projects.
4. Collaboration in the area of academic publications, research activities, field trips etc. with the faculties, students and research scholars.
5. To hold and organize National and International Conferences.
6. Other activities of mutual interest regarding academic or scientific and technological research matters.
7. The conveyance charges, fooding and lodging arrangements will be made by the respective organizations/ institutions from its own fund where the venue to be held.
8. If additional assistance is required, both the organizations/ institutions will settle mutually after discussions.

III. Execution of the Agreement

The specific activities to be carried out under this agreement will be stated in corresponding specific sub-agreements. Such specific sub-agreements, once approved by both parties, will be attached as annexes to this agreement.

III. Execution of the Agreement

The specific activities to be carried out under this agreement will be stated in corresponding specific sub-agreements. Such specific sub-agreements, once approved by both parties, will be attached as annexes to this agreement.

The specific sub-agreements between both universities will specify their objectives, conditions and ways of execution, financial support, period the sub-agreement will be in effect, and administrative responsibility within each institution.

IV. Term and Expiration of the Agreement

It is understood that this agreement will come into effect after being signed by both Parties and will be established for a period of five years. After this five year it will be automatically extended for an indefinite period, unless one of the Parties expresses an intention (by written notification) to cancel the agreement at least (3) three months before the expiry date.

Any additions, changes, or deletions to this document must be approved by these representatives of both organisations. All notices shall be in writing and shall be directed to these individuals as follows:

The amendment, termination and expiration of this MoU will not affect the terms of activities ongoing at the time of notification of amendment, termination or expiration, unless otherwise agreed upon between the parties.

V. NON-EXCLUSIVITY:

This Agreement is a non-exclusive agreement, and both parties remain free to enter into similar agreements with third parties.

VI. SPECIAL PROVISIONS

1. Each party will take approval from the other party in writing prior to using the latter's name and logo for the activities hereunder on a case-by-case basis.
2. All parties hereto shall do their utmost to ensure the smooth and efficient implementation of the programs.
3. The parties will consult with each other for any subsequent associated agreement informally and attempt to resolve disputes or misunderstandings that may arise in the administration of this MoU or any subsequent associated agreement informally.
4. Neither party can misuse this MoU by involving the name of the other without the written consent from the other party.

VII. DISPUTES

If any dispute aris in respect of the MoU, in that case both the organisations will discuss and settle the matter amicably.

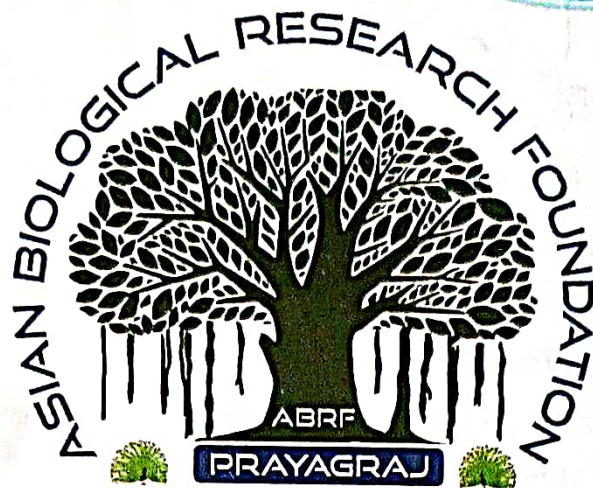
